		Trustee Drover indicated he was very impressed with The Leader in Me initiative. Trustee Adams thanked all of the students for attending the meeting and acknowledged their self confidence in public speaking, indicating this was a very valuable life skill. Chair, Jeff Thompson, thanked staff for all of their hard work in successful implementation of initiatives such as this one.
	District Initiatives 1. Computers for Schools (Ali Syed)	Associate Superintendent, Brenda Sautner, introduced the District IT Director, Ali Syed. Mr. Syed provided a snapshot of District technology advances, aknowledging and thanking ATCO for a large equipment donation. The donated equipment included laser printers, laptops, desktop computers, LCD flatscreen monitors, keyboards, mice and cabling.
		All Grade 9 students at Composite High School are part of a 1:1 laptop computer five- year grant. Class sets have also been slated for Greely Road, Beacon Hill, Fort McMurray Christian School, Westview, Westwood, Timberlea and Ecole Dickinsfield. Mr. Syed also updated trustees and senior management that old computers are being cleaned of data and are either recycled or sent to the Philippines for use in their rural schools.
		Mr. Syed indicated technological changes have also resulted in significantly reducing the students' log in and log off times on computers.
