Whereas in its 2017 Federal Deficit Budget, the Federal Government has eliminated the Municipal Officer's Expense Allowance; and

Whereas the Board of FMPSD, has elected to use this provision as a method to keep Board remuneration costs low as a fiscal measure to keep more dollars flowing into the classroom; and

Whereas trustees have themselves elected to be the lowest compensated elected officials; and

Whereas Trustees may not necessarily anticipate a salary increase during the term of their office, and have in the past on many occasions elected not to take proposed increases during their term, they do not expect a decrease in remuneration;

I would move that effective January 1,2019, the monthly honorarium for Chair be set at \$2,288.00, for Vice Chair \$2,225.00, and for other trustees \$2,162.00, and that the per diem received by Trustees who are assigned meetings by the Board that regularly take them out of the Community be set at \$75 per day with the net result being that trustees should not see a change in their net pay after taxes.

A thorough discussion and debate was held on the topic including multiple questions that were asked of Trustees and the Superintendent and answered.
